#### ROB FRERES PRESIDENT

Robert "Rob" Freres Jr. is president of Freres Engineered Wood; member of Evergreen Biopower LLC; and board member of the Freres Foundation. Rob is a life-long leader and outspoken advocate of the wood products industry, having witnessed the demise of hundreds of mills since the 1990s, and the collapse of the

social structure of 130 timber-dependent communities in the Pacific Northwest. Since that time, Rob has actively pursued securing a timberland base and increased ownership acres four fold.

Rob is an active member of the Board of Visitors of Oregon State University's College of Forestry; former chair of the American Forest Resource Council; a 38-year executive board member of Associated Oregon Industries; past president of the Small Business Timber Council; a former board member of the Oregon Forest Resources Institute; and past president of NW Timber Association. Rob also served his community as a decade-long board member of the Regis Foundation, which supports the Regis St. Mary Catholic School system in Stayton, Oregon.

Rob grew up in Stayton, and earned a B.S. in Business from Southern Oregon State College in 1979. He attended Willamette University in Salem and in 1983, served on Senator Mark Hatfield staff in Washington D.C.

Rob has worked his way up through the family business, from sweeping floors at age 10, to working in every capacity in veneer mills through high school. Rob gained experience in logging and road building during his college years.

Today, he is delighted to see the company through the introduction of their Mass Ply product and facility. "This new facility has the veneer segment in the Pacific Northwest ecstatic over the expanded use of veneer," says Rob. "... and it has the world a-buzz about the possibilities with mass timber construction."
